PACE Washington Enrollment Agreement

**2026-2027 School Year**

By enrolling my child in PACE Washington (hereinafter referred to as "PACE"), I acknowledge and agree to the following terms and conditions:

- Financial Responsibility:** I acknowledge that I am personally responsible for all financial obligations, including tuition and fees, incurred for the 2026-2027 academic year. I agree to pay all tuition and fees as per the established tuition schedule. I understand that tuition is a commitment for the entire academic year.
- Liability for Damages & Lost Property:** I accept full responsibility for any damages caused by my child. I understand that PACE is not responsible for any lost, stolen, or damaged personal belongings.
- Compliance with School Policies:** I will read and adhere to the PACE Handbook, supporting the school’s mission, Islamic values, and policies. I will work in partnership with the school to ensure compliance with all rules and guidelines.
- Code of Conduct & Disciplinary Policy:** I agree to abide by the PACE Code of Conduct and Discipline Policy, as outlined in the Handbook. I acknowledge that PACE has the authority to discipline my child in a manner deemed appropriate and in accordance with the school’s standards.
- Student Release Policy:** I understand that my child will only be released to individuals listed on the Student Registration and Carpool Form, including designated emergency contacts. The authorized person picking up my child must be at least 18 years of age and must present a valid photo ID upon request.
- Parental Involvement & Partnership:** I commit to being actively engaged in my child’s education and will uphold the PACE Partnership Pledge.
- Field Trips & School Activities:** I grant permission for my child to participate in scheduled field trips and school activities. I understand that I must complete a Liability Release Form and Permission Slip before my child is allowed to participate in any off-campus PACE activity.

8. **Supervised Outdoor Walks:** I grant permission for my child to take supervised walks on the MAPS premises and surrounding areas (within a 1-mile radius) under the supervision of PACE staff and volunteers.
9. **Photography & Media Release:** I grant permission for my child to be included in school-related photographs and videos for internal use (e.g., school events, parent viewing, staff documentation). I understand that any media used for public purposes (e.g., advertisements, publications, the school website) will require my explicit consent.
10. **Social media & Online Conduct:** I understand that any form of inappropriate, defamatory, or irresponsible behavior involving PACE, its staff, students, or families on social media or any online platform is strictly prohibited. Negative, misleading, or harmful content that violates the school’s Islamic values, code of conduct, or disrupts the school community may result in disciplinary action, up to and including dismissal from PACE.
11. **Health & Sickness Policy:** I acknowledge the importance of adhering to the PACE sickness policy. If my child exhibits symptoms of illness, I will arrange for their prompt pickup from school.
12. **Student Conduct & Islamic Values:** I understand that PACE upholds Islamic values and moral conduct. Any student behavior that contradicts fundamental Islamic principles, disrupts the learning environment, or negatively impacts the school community may result in disciplinary action, including dismissal.
13. **Delinquent Accounts & Parent Conduct:** I acknowledge that failure to maintain my financial obligations or engaging in disruptive or inappropriate behavior as a parent may result in my child’s dismissal from PACE.
14. **Non-Discrimination & Admission Policy:** PACE admits students of all races, colors, nationalities, and ethnic backgrounds. However, the school reserves the right to deny admission or dismiss students and/or families who do not align with PACE’s Islamic code of conduct, academic standards, and school policies.
15. **Financial Assistance:** May be available; however, requests must be made prior to admission. Requests submitted after enrollment will not be considered. To apply, families must submit a written request detailing their financial need along with a copy of the previous year’s tax return. PACE will assess eligibility based on Federal Poverty Guidelines and the availability of funds. If approved, financial assistance may be granted in full or partially for a maximum of one year or less, depending on circumstances. Families must reapply at least four (4) months before the program start date for continued assistance.
16. **Facility & Operational Continuity Fee:** To help sustain our program and support recent increases in facility costs, a small month Facility & Operational Continuity Fee will be added beginning in the 2026–2027 academic year. spreading this amount into small monthly increments, we aim to make it manageable for families while ensuring the continued strength and stability of the PACE community.
